### 4. First-aid measures

<b>Inhalation</b>	Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a poison center or doctor/physician if you feel unwell.

### 5. Fire-fighting measures

### 6. Accidental release measures

**Methods and materials for containment and cleaning up** Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Ventilate the contaminated area. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Minimize dust generation and accumulation. Wear appropriate protective equipment and clothing during clean-up. This product is miscible in water.

Large Spills: Wet down with water and dike for later disposal. Shovel the material into waste container. Following product recovery, flush area with water.

Small Spills: Sweep up or vacuum up spillage and collect in suitable container for disposal. Clean surface thoroughly to remove residual contamination.

Never return spills to original containers for re-use. For waste disposal, see section 13 of the SDS. Stop leak if you can do so without risk. Keep combustibles (wood, paper, oil, etc.) away from spilled material. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Prevent entry into waterways, sewer, basements or confined areas. Clean up in accordance with all applicable regulations.

## 7. Handling and storage

**Precautions for safe handling** Minimize dust generation and accumulation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Keep away from heat. Provide appropriate exhaust ventilation at places where dust is formed. Take any precaution to avoid mixing with combustibles. Keep away from clothing and other combustible materials. Avoid breathing dust. Avoid contact with eyes, skin, and clothing. Wear appropriate personal protective equipment. Observe good industrial hygiene practices.

**Conditions for safe storage, including any incompatibilities** Store locked up. Keep away from heat. Store in a cool, dry place out of direct sunlight. Store in tightly closed container. Store in a well-ventilated place. Do not store near combustible materials. Store away from incompatible materials (see Section 10 of the SDS).

## 8. Exposure controls/personal protection
