### 4. First-aid measures

<b>Methods and materials for containment and cleaning up</b>	Stop leak if you can do so without risk. Keep combustibles (wood, paper, oil, etc.) away from spilled material. This product is miscible in water. Dilute with water. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Sweep up or vacuum up spillage and collect in suitable container for disposal. Collect dust using a vacuum cleaner equipped with HEPA filter. Avoid the generation of dusts during clean-up. Following product recovery, flush area with water. Prevent entry into waterways, sewer, basements or confined areas. Clean up in accordance with all applicable regulations. ### Precautions for safe handling
