Methods and materials for containment and cleaning up	Eliminate all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop the flow of material, if this is without risk. Dike far ahead of spill for later disposal. Prevent entry into waterways, sewer, basements or confined areas. Avoid dust formation. Small Dry Spills: With clean shovel place material into clean, dry container and cover loosely; move containers from spill area. If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product. Collect dust using a vacuum cleaner equipped with HEPA filter. Following product recovery, flush area with water.
Environmental precautions	Avoid discharge into drains, water courses or onto the ground.

Precautions for safe handling	Keep away from heat. Provide appropriate exhaust ventilation at places where dust is formed. Minimize dust generation and accumulation. Avoid breathing dust. Avoid contact with eyes. Practice good housekeeping. Keep in air-tight containers- material is hygroscopic.
Conditions for safe storage, including any incompatibilities	Store in original tightly closed container. Store in a well-ventilated place. Store away from strong oxidizers. Store away from incompatible materials (see Section 10 of the SDS). Protect from moisture. To protect purity, store under dry nitrogen gas. Keep away from heat.
