## 4. First Aid Measures

**First aid procedures**

**Eye contact** Rinse with water. Get medical attention if irritation develops or persists.

**Skin contact** Rinse skin with water/shower. Get medical attention if irritation develops or persists.

**Inhalation** If gas/fume/vapor/dust/mist from the material is inhaled, remove the affected person immediately to fresh air. Call a physician if symptoms develop or persist.

**Ingestion** Have victim rinse mouth thoroughly with water. Never give anything by mouth to a victim who is unconscious or is having convulsions. Do not induce vomiting without advice from poison control center. If vomiting occurs naturally, have victim lean forward to reduce risk of aspiration. Do not use mouth-to-mouth method if victim ingested the substance. Induce artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. If material is ingested, immediately contact a poison control center.

## 5. Fire Fighting Measures

<b>Suitable extinguishing media</b>	Water. Water fog. Foam. Dry chemical powder. Carbon dioxide (CO <sub>2</sub> ).
<b>Protection of firefighters</b>	
<b>Protective equipment and precautions for firefighters</b>	In the event of fire, cool tanks with water spray. Use water spray to cool unopened containers. Cool containers exposed to flames with water until well after the fire is out.
<b>Specific methods</b>	In the event of fire, cool tanks with water spray. Use water spray to cool unopened containers.

## 6. Accidental Release Measures

<b>Personal precautions</b>	Keep unnecessary personnel away. Local authorities should be advised if significant spillages cannot be contained. Avoid inhalation of dust from the spilled material. Wear a dust mask if dust is generated above exposure limits.
<b>Environmental precautions</b>	Prevent further leakage or spillage if safe to do so.
<b>Methods for containment</b>	If sweeping of a contaminated area is necessary use a dust suppressant agent which does not react with the product.
<b>Methods for cleaning up</b>	Sweep up or vacuum up spillage and collect in suitable container for disposal. Avoid dust formation. Collect dust or particulates using a vacuum cleaner with a HEPA filter. Following product recovery, flush area with water.

## 7. Handling and Storage

<b>Handling</b>	Keep formation of airborne dusts to a minimum. Provide appropriate exhaust ventilation at places where dust is formed. Do not breathe dust from this material. Avoid contact with eyes. In case of insufficient ventilation, wear suitable respiratory equipment. Wash thoroughly after handling. Handle and open container with care.
<b>Storage</b>	Store in a well-ventilated place. Keep container tightly closed. Guard against dust accumulation of this material. Use care in handling/storage.

## 8. Exposure Controls / Personal Protection

<b>Engineering controls</b>	Ventilation should be sufficient to effectively remove and prevent buildup of any dusts or fumes that may be generated during handling or thermal processing. If engineering measures are not sufficient to maintain concentrations of dust particulates below the OEL, suitable respiratory protection must be worn. If material is ground, cut, or used in any operation which may generate dusts, use appropriate local exhaust ventilation to keep exposures below the recommended exposure limits. Ensure adequate ventilation, especially in confined areas.
